SIG enjoys a long-time broker/third party administrator relationship to provide services of:

• P/L TPA

- Retail brokerage services for Liability coverage and the ancillary lines of coverage for Crime, Cyber Liability/Breach Response, and Non-Owned Aviation
- Retail brokerage services for Workers Compensation coverage
- P/L and WC Risk Management services

The brokerage, Woodruff Sawyer, has notified SIG of their intent to terminate coverage in alignment with the contract's 90-day termination clause, to be effective April 12, 2021.

Because SIG is in the middle of marketing for the 2021-2022 program year, this contract termination exposes SIG to potential disruption in the marketplace. It is vital that SIG obtain competitive contract bids as soon as possible to avoid a gap in the renewal marketing process.

A RFP timeline is included for review. A draft RFP will be provided by handout.
